Comptroller Lierman Celebrates Opening of New Branch Office in Baltimore County

Windsor Mill location to increase access to agency services, convenience for Marylanders

ANNAPOLIS, Md. (November 6, 2025) — **Comptroller Brooke E. Lierman** today joined state and local leaders to cut the ribbon for the Maryland Office of the Comptroller's <u>new Baltimore County Branch Office</u> in Windsor Mill — a milestone in the agency's mission to modernize government services and make tax assistance more accessible for Marylanders.

"This relocation is more than a new address," said **Comptroller Lierman**. "We are advancing equitable tax administration by making our services more accessible, providing modern spaces for our team members and customers, and building a stronger connection with the people of Baltimore County."

The Comptroller was joined by Maryland Department of General Services Secretary Atif Chaudhry, Speaker Pro Tem Dana Stein, State Senator Charles Sydnor III, Baltimore County Executive Kathy Klausmeier, Baltimore County Councilman Julian Jones, Robin McKinney of the CASH Campaign of Maryland, and other community partners for the ribbon-cutting.

"I am elated to have a branch of the Comptroller's office here in Western Baltimore County serving the citizens of Maryland," shared **Senator Sydnor**.

"Residents deserve a space where they can consult with experts, get advice, and seek help with their taxes," **County Executive Klausmeier** said. "The Maryland Office of the Comptroller's new Branch Office in Windsor Mill – conveniently located off of Exit 18 on the Beltway, is a modern and accessible resource that will answer taxpayer questions so that families and communities across the county can continue to be successful."

The Windsor Mill Branch Office, which officially opened to the public on October 20, replaces the former branch office in Towson that had served taxpayers for over three decades. The new office offers ground-floor access, free parking, proximity to I-695, and accessibility by public transit, significantly improving convenience for Baltimore County residents and nearby communities.

The Comptroller noted that more than 112,568 taxpayers have visited the agency's 11 branch offices so far in 2025, with over 3,600 taxpayers assisted virtually.

"Marylanders want to be able to talk to a real person, in a modern and welcoming space, when they need help with their taxes," Comptroller Lierman said. "By investing in these new facilities, we are meeting people where they are, improving accessibility, and strengthening the relationships that make our agency a trusted resource for Maryland families and businesses."

"We are honored to welcome the State of Maryland Comptroller's Office to Executive Park West," **Brent Mangum**, Vice President of Office Leasing for David S. Brown Enterprises, LTD said. "Their selection of this location underscores Executive Park West's reputation as a premier business environment offering superior accessibility, modern infrastructure, and a professional setting well-suited to the needs of distinguished state agencies."

The Office of the Comptroller is planning three additional office relocations in 2026.

"At the Department of General Services, we take great pride in ensuring that leaders like Governor Moore and Comptroller Lierman have the resources they need to succeed—whether that means modern office space, streamlined operations, or the tools to better serve Marylanders," **Secretary Chaudhry** shared. "Together, we've transformed vision into reality—a space that represents not just accessibility and innovation, but our collective mission to modernize Maryland's public facilities and deliver services that truly reach every resident."

Marylanders are encouraged to visit any of the Comptroller of Maryland branch offices, which are open Monday through Friday, 8:30 a.m. to 4:30 p.m.

Branch offices provide the following services without a scheduled appointment:

- Blank Maryland state tax forms and/or tax booklets
- Answers for general tax questions
- Accept completed Maryland tax returns and/or requested documents
- IFTA decals for carriers in good standing and new carriers with approved applications.
- Certified copies of previously filed Maryland tax returns for individuals with identification.
